We agree to receive, set up, and manage the sales of the merchandise supplied. We agree to sell only at the listed prices. We agree to be responsible to inventory and return the product and monies as outlined in the packing list.

The shipping will be paid by Emphasis Sports Marketing for the delivery to a destination address that must be determined no later than 1 week prior to the event.

We agree that we will return the product and monies within <u>two (2) days</u> of the end of our event, to be received no later than <u>five (5) days</u> after the event. *Payment is due when the goods are returned*. A cheque made out to Emphasis Sports Marketing can be enclosed with the completed inventory and paperwork. Prior agreement and approval for Visa or Mastercard can also be arranged.

**BONUS:** If goods are received undamaged, and payment received no later than five (5) working days after the conclusion of the event, and the inventory and payment amounts are accurate, a bonus of five percent (5%) of your sales will be issued to your sports association in the form of a cheque from Emphasis Sports Marketing, for deposit to the association bank account. Any discrepancies will be deducted from any potential bonus.

We agree to use the Emphasis Sports Marketing Inventory forms to calculate the merchandise sold less our 20% consignment fee. We further agree to return the merchandise in salable, brand new condition.

We agree to be responsible for the return shipping costs to Emphasis Sports Marketing via Canada Post Expedited or an equivalent courier service

We agree that there will be a penalty of five percent (5%) against the associations already earned monies, if the goods or payment are not received within seven (7) working days of the end of our event, to be charged to the association. This late fee will be charged repeatedly each week until all merchandise is returned and payment in full has been received.
